REMARKS:

- (1) As a result of the completion on April 17, 2003 of a dual listed company transaction (the "DLC Transaction") between Carnival Corporation and Carnival plc, each share of Carnival Corporation common stock is paired with non-detachable trust shares of beneficial interest in P&O Princess Special Voting Trust.
- (2) Represents trust shares (the "Trust Shares") of beneficial interests in Carnival plc Special Voting Trust (the "Trust"). In connection with the DLC Transaction, Carnival plc issued one special voting share to the Trust and, following a series of transactions, the Trust Shares were distributed to holders of common stock of Carnival Corporation (the "Carnival Corporation Common Stock"). Following the completion of the DLC Transaction, if Carnival Corporation issues Carnival Corporation Common Stock to a person, the Trust will issue an equivalent number of Trust Shares to such person. The Trust Shares are paired with shares of Carnival Corporation Common Stock and are represented by the same stock certificate. The Trust Shares represent a beneficial interest in the Carnival plc special voting share.
